Part of Jet Blue, the leading USA based Airline, Live TV is the world's leading provider of live in-flight entertainment and connectivity systems for commercial airlines. Founded in 1998 in Melbourne, Florida, Live TV has grown to include installation and maintenance locations around the world to support the more than 600 aircraft equipped with its products. For more than a decade, passengers have been enjoying these products while traveling with industry leaders like JetBlue, United, Frontier, Alitalia, Virgin Australia, WestJet and Azul.

Live TV was founded on the idea that satellite television onboard commercial aircraft could provide a more comfortable and enjoyable travel experience for the millions of airline passengers that take to the skies each year. This concept has seen Live TV grow from a small high-tech start-up into a global operation with hundreds of employees, one that is well versed in the challenges of successfully managing a rapidly expanding organization.

#### THE CHALLENGE

Bound by PCI Compliance, which requires all organizations processing credit card transactions to adhere to a set of regulatory requirements that place controls around the information, Live TV needed a solution that could scale effectively as the exponential growth of the company meant that they were going from being a Level 3 merchant processing between 20,000 to 1 million transactions a year to a Level 1 merchant processing more than 6 million transactions, and needed to be compliant as such in a very short space of time.

Software was already in place to manage the 88 devices that were within the PCI scope as a Level 3 merchant, but the jump to Level 1 status meant the in-scope PCI environment expanded to 363 devices.

# THE SOLUTION

The initial step was to approach the incumbent software provider (Tripwire ®) to expand the existing installation but the cost was way beyond budget expectations, so still reeling from this Julian Cortez at Live TV, looked to the market for alternatives.

With a PCI audit looming, Julian needed to find a solution for Live TV that could meet their functional requirements and be installed in a very short timescale, yet not cost the earth. At this point sister company jetBlue Airways, recommended they take a look at NNT and their Change Tracker software solution.

Julian explains the situation, "At first I couldn't believe the position Tripwire ® had put us in, but it all worked out for the best in the end. We now have a solution that ticks all the boxes from the IT security and PCI compliance perspective, one that is much easier to use and able to scale effectively as and when we need the capacity. The solution provides Live TV with an easy to use system that can monitor all unexpected system changes, including changes to files, registry keys and values, processes, services and other configuration settings in real-time. The system highlights what the threats are, what the risk profile is, what has changed and who made the change, and whether or not it was planned or unplanned.

The forensic level of detail provided means that Live TV can rest safe in the knowledge that the PCI environment is secure and compliant at all times.
